2017 Notice of EAP

- Mailing began April 24, 2017
- No installment or exposure information
- Directed to www.bwc.ohio.gov
- Certificate reprints available July 1
- Changes and/or corrections permitted
- First installment is due July 3, 2017 for all installment plans

BWC E-account

- E-account user ID and password
 - Different from your policy number
 - User specific
 - Primary user
 - Secondary user
- E-account gives you access to claim and policy information
 - Report and pay online
 - Review individual claims and transaction history
 - Complete year-end true-up

Private Employer Early Payment Discount

- Effective July 1, 2017
- Policy must be in active coverage status
- Any installment plan
- 2017 premium paid in full
- Payment received by July 3, 2017
- 2% uncapped discount

*Employers are NOT required to sign up

Early Payment Discount Cont.

- BWC will calculate and post the discount approximately 10 days after the due date
- BWC will apply the credit to any balance due at the time it posts

Future Dating of Payments

- Allows employers to schedule the premium payment on www.bwc.ohio.gov
- Bank transactions, automated clearing house (ACH) only
- No credit card payments
- Employer selects payment date
- Lessens the potential to miss a payment
- Roll-out planned for late June

Website Payment Transaction Tips

- Payment blocked by your bank
- ACH transactions only
- Bank may require an authorization code from BWC
 - Employer's responsibility to provide to your bank
- Debit blocker code: #3311334187

Website Payment Transaction Tips Con't.

- BWC has no limits on credit card transactions
- Credit card company:
 - Imposes transaction limits
 - Denies transactions
- Large transactions - notify the credit card company
- Be sure to finish the transaction
