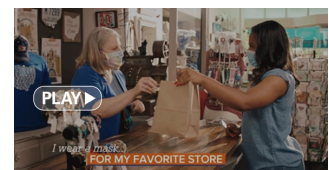

#### Updated BWC website coming soon

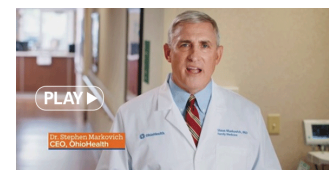

## Guidance on Silica Safety Standards

OSHA recently released an [OSHA Instruction](#) document titled “Inspection Procedures for the Respirable Crystalline Silica Standards.” The directive (CPL 02-02-080) provides OSHA inspection officers with guidance on enforcement of silica standard requirements, including clarification on specific topics such as sampling, temporary workers, and alternative exposure control methods.

## Firefighter Fatality Report – 2019

---

The NFPA report on 2019 firefighter fatalities in the U.S. found there were 48 firefighter fatalities, 25 volunteer firefighter fatalities, 22 sudden cardiac deaths, and three road crash fatalities.
