

Distribution of public employer rebates by county and industry

The Ohio Bureau of Workers' Compensation (BWC) would return an estimated \$113 million to 3,900 public employer taxing districts under the \$1 billion rebate proposed by Governor John Kasich and Administrator/CEO Steve Buehrer. The rebate is part a \$1.9 billion proposal that also includes tripling safety grants and a 4 percent rate reduction for public employers that will be made possible through modernization of BWC operations.

On the following pages, you will see three tables that help you understand where that \$113 million is going. Please note that the amounts are estimates. The first table shows the estimated total amount being distributed to each county. The second table shows the amount being distributed to each industry included in the definition of a public employer taxing district. The final table shows a county-by-county breakdown by these industries.
