**\*\*If parties agree the condition is the same, forward to the AG.**

**If requesting parties disagree that the condition is the same, issue decision.**

**Note: Settlement requests filed on a C-240 application will be dismissed for claims located at the AG's Office, which are pending a court proceeding.**
